**INVITATION TO SUBMIT PROPOSALS FOR THE CONSIGNMENT OF MEDICAL DEVICES AND SUPPLIES FOR THE CATHETERIZATION LABORATORY, OPERATING ROOM SECTION, AND PERFUSION SECTION**

1. The Mariano Marcos Memorial Hospital and Medical Center (MMMh and MC), City of Batac, Ilocos Norte invites proposals for the Consignment of various Medical Devices and Supplies indicated in Annex A (consignment list) from duly qualified suppliers for a period of 12 months.
2. Suppliers must have a valid License to Operate from the Food and Drug Administration and have at least satisfactory completed consignment agreements or procurement or machine tie up contracts of at least twenty five percent (25%) of the estimated cost of the goods that the Supplier is willing to consign from a single agreement/contract or from an aggregate amount from three (3) agreements/contracts within the last three (3) years from the date of submission and receipt of proposals.
3. Selection shall be based on pass/fail and compliance/non-compliance criteria and determination of the most responsive offer in terms of technical specification, compliance and price. Request is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA5183.

5. A checklist of the complete set of Consignment Documents is attached on Annex B.

Consignment proposals, thru a properly filled up consignment proposal form in Annex C and D, including legal, financial and technical documents as indicated in the attached checklist, kindly provide a filled-up checklist and arrange the documents in order. **HARD COPY** must be duly received by the Consignment Committee on or before 1:00 PM on **August 22, 2022**. The above documents must be sent or delivered in a sealed envelope to the Consignment Selection and Awards Committee (CSAC) **secretariat**, Ground Floor, Main Building, Pharmacy Satellite, Mariano Marcos Memorial Hospital and Medical Center, Brgy. 6 San Julian, City of Batac, Ilocos Norte, on or before **August 22, 2022**. Opening of the proposals shall be opened to prospective consignors and to all interested parties. Proposal opening shall be on **August 22, 2022, 1:30PM at the MMMH & MC, Operations Center, 5<sup>th</sup> Floor Laboratory Bldg.**
7. Proposals will be opened in the presence of the supplier's representative/s who choose to attend at the address above subject to hospital memorandum no. 262 s. 2020 (Annex E). **Late proposals shall not be accepted.**
8. The MMMH and MC reserve the right to reject any and all proposals, declare a failure of consignment or not forge and Agreement without thereby incurring any liability to the affected Supplier/s.
