INVITATION TO BID FOR MEDICAL EQUIPMENT

1. The *Mariano Marcos Memorial Hospital and Medical Center*, through the *HFEP 2018 and Income Fund*¹ intends to apply the sum of *four million four hundred twelve thousand five hundred sixty pesos only (Php 4,412,560.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Medical Equipment, to include the following*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1 unit Mechanical Ventilator	P 2,200,000.00
1 unit ENT Treatment	1,500,000.00
1 unit Patient Lifter	300,000.00
25 units Overbed Table	375,000.00
2 units Pulse Oximeter	37,560.00

2. The *Mariano Marcos Memorial Hospital and Medical Center* now invites bids for *Medical Equipment (Mechanical Ventilator; ENT Treatment Unit; Patient Lifter; Overbed Table; and Pulse Oximeter)*.² Delivery of the Goods is required *within sixty (60) calendar days*. Bidders should have completed, within *two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from *Procurement Section, Mariano Marcos Memorial Hospital and Medical Center* and inspect the Bidding Documents at the address given below during *8:00 AM – 12:00 NN and 1:00 PM – 5:00 PM*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **Mariano Marcos Memorial Hospital and Medical Center** will hold a Pre-Bid Conference³ on **February 21, 2018, Wednesday at 2:00 PM at the Board Room, Second Floor Main Building of Mariano Marcos Memorial Hospital and Medical Center** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **March 7, 2018 at 1:00 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.
- Bid opening shall be on **March 7, 2018 at 2:00 PM at the Board Room, Second Floor Main Building of Mariano Marcos Memorial Hospital and Medical Center**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **Mariano Marcos Memorial Hospital and Medical Center** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


