

CONTRACT AGREEMENT

THIS AGREEMENT made the ____ day of MAR 04 2021 between **MARIANO MARCOS MEMORIAL HOSPITAL AND MEDICAL CENTER, Brgy. 6 San Julian, City of Batac, Ilocos Norte** of the Philippines (hereinafter called "the Entity") of the one part and **SERVO-TREAT PHILIPPINES, INC. of Zone 6, Barangay Pinmaludpod, Urdaneta City, Pangasinan** (hereinafter called "the Supplier") of the other part;

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

The **Mariano Marcos Memorial Hospital and Medical Center** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






