INVITATION TO BID FOR *Preventive Maintenance and Repair Services of Generator Sets, Automatic Transfer Switch and Distribution Transformers (Re-Bid)*

1. The *Mariano Marcos Memorial Hospital and Medical Center*, through the *Hospital’s Income* intends to apply the sum of *Three Million Seven Hundred Sixty-One Thousand Three Hundred Fifteen Pesos and 26/100 (P3,761,315.26)* being the ABC to payments under the contract for *Preventive Maintenance and Repair Services of Generator Sets, Automatic Transfer Switch and Distribution Transformers (Re-Bid)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Mariano Marcos Memorial Hospital and Medical Center* now invites bids for the above Procurement Project. Delivery of the Goods is required *based on the specified delivery schedule in the Bidding Documents*. Bidders should have completed, within *the last two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from *Procurement Section, Mariano Marcos Memorial Hospital and Medical Center* and inspect the Bidding Documents at the address given below during *8:00 AM – 12:00 NN and 1:00 PM – 5:00 PM*.
5. A complete set of Bidding Documents in the form of Electronic Copy may be acquired by interested Bidders *starting October 13 to November 2, 2022 until 5:00PM* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, shown below:*

The *Mariano Marcos Memorial Hospital and Medical Center* will hold a Pre-Bid Conference on *October 20, 2022, Thursday, 9:00AM* through video conferencing or webcasting via *Cisco Webex (Meeting Code:2514 896 7993; Password: BACB)* which shall be open to prospective bidders. Moreover, interested bidders may submit their active email address at the given email and contact number below.
8. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before *November 3,2022, Thursday, 9:00AM*. Late bids shall not be accepted.
9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
10. Bid opening shall be on *November 3,2022, Thursday, 9:30AM at 2nd Floor, Board Room, Main Building of Mariano Marcos Memorial Hospital and Medical Center* and it will also be done through video conferencing or webcasting via *Cisco Webex (link to be sent thru email)* for those bidder’s who cannot attend the activity. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity. *Only one (1) representative* shall be allowed to attend the said activity. Representative who will attend shall observe proper health protocols (*i.e. wearing of face mask, face shield and observe social distancing*).

The *Mariano Marcos Memorial Hospital and Medical Center* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.


