INVITATION TO BID FOR MICRO DATA CENTER PHASE I - SUPPLY, DELIVERY, INTEGRATION, INSTALLATION AND CONFIGURATION OF HYPER CONVERGE INFRASTRUCTURE (HCI) WITH DISASTER RECOVERY (DR) SOFTWARE

1. The *Mariano Marcos Memorial Hospital and Medical Center*, through the **HFEP 2021 (Short of Award)** intends to apply the sum of **₱ 15,000,000.00** being the ABC to payments under the contract for *Micro Data Center Phase I - Supply, Delivery, Integration, Installation and Configuration of Hyper Converge Infrastructure (HCI) With Disaster Recovery (DR) Software per Project ID Number ITB2020-022*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Mariano Marcos Memorial Hospital and Medical Center* now invites bids for the above Procurement Project. Delivery of the Goods is required by **90 calendar days from the receipt of the Notice to Proceed**. Bidders should have completed, within **2 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *Mariano Marcos Memorial Hospital and Medical Center* and inspect the Bidding Documents at the address given below during **8:00 AM to 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **December 4, 2020 to December 23, 2020** from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person, by facsimile, or through electronic means*.

6. The ***Mariano Marcos Memorial Hospital and Medical Center*** will hold a Pre-Bid Conference¹ on ***December 11, 2020 at 2:00 PM at Board Room, 2nd Floor Main Building of MMMH & MC*** and/or through video conferencing or webcasting via *Google Meet*, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before ***December 23, 2020 at 1:30 PM***. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on ***December 23, 2020 at 2:00 PM at Board Room, 2nd Floor Main Building of MMMH and MC*** and/or via *Google Meet*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.


