INVITATION FOR NEGOTIATED PROCUREMENT FUEL, OILS AND LUBRICANTS FOR HOSPITAL VEHICLES AND GENERATOR SETS

In view of two (2) failed public biddings, the Mariano Marcos Memorial Hospital and Medical Center – Bids and Awards Committee (BAC) invites interested bidders to participate in the negotiation for the project, **"Fuel, Oils and Lubricants for Hospital Vehicles and Generator Sets"**, in accordance with Section 53.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act." The Mariano Marcos Memorial Hospital and Medical Center intends with a credit limit of **One Million Pesos Only (P 1,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Project. The funding source is through the authorized appropriations under the Income Trust Fund.
