3. Supplies are required to submit the following prior to the notification by the BAC of the award: a) Valid and Current Mayor's/Business Permit; b) Valid and Current PhilGEPS Registration Certificate/Number; c) Income/Business Tax Return; and, d) Omnibus Sworn Statement.

4. Retention: The obligation for the warranty shall be covered either retention money in an amount equivalent to at least one percent (1%) of every progress payment, or a special bank guarantee equivalent to at least one percent (1%) of the contract price. The said amounts shall only be released after the lapse of the warranty period or in case of expendable supplies, after consumption thereof; provided, however, that the supplies delivered are free from patent and latent defects and all the conditions imposed under the contract have been fully met.
