**PROCUREMENT OF VARIOUS DRUGS AND MEDICINES**

WHEREAS, the Pharmacy section of Mariano Marcos Memorial Hospital and Medical Center requested for the Procurement of Various Drugs and Medicines under Purchase Request (PR) Nos. 2022-10-037;

WHEREAS, the Purchase Request was approved by the Chief of Medical Professional Staff;

WHEREAS, the BAC received the approved Purchase Request, hence, the committee convened to determine what mode of procurement shall be used for Procurement of Various Drugs and Medicines;

WHEREAS, in reference to the provision of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, Otherwise Known as the Government Procurement Reform Act, the BAC agreed to use Alternative Method of Procurement, as stated below;

*Section. 53. Negotiated Procurement is a method of procurement of Goods, Infrastructure Projects and Consulting services, whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant ...*

*53.8.a Small Value Procurement. Procurement of (a) goods not covered by Shopping under Section 52 of the IRR of RA 9184, (b) infrastructure projects, and (c) consulting services, wherein the amount involved does not exceed the threshold.*

WHEREAS, after thorough review of RA 9184 and its revised IRR, the BAC unanimously agreed that Procurement of Various Drugs and Medicines is through "Negotiated – Small Value Procurement";

NOW THEREFORE, on the basis of the foregoing, the herein members of the Bids and Awards Committee HEREBY RESOLVE as it is resolved to recommend that the Procurement of Various Drugs and Medicines will be procured through Negotiated – Small Value Procurement.
