PROCUREMENT OF REVERSE OSMOSIS SYSTEM 2000 GPD WITH INSTALLATION

WHEREAS, the Operating Room (OR) section of Mariano Marcos Memorial Hospital and Medical Center requested for the Procurement of Reverse Osmosis System 2000 GPD with Installation under **Purchase Request (PR) No. 2022-10-062**;

WHEREAS, the Purchase Request was approved by the Chief Nurse;

WHEREAS, the BAC received the approved Purchase Request, hence, the committee convened to determine what mode of Procurement of Reverse Osmosis System 2000 GPD with Installation;

WHEREAS, in reference to the provision of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, Otherwise Known as the Government Procurement Reform Act, the BAC agreed to use Alternative Method of Procurement, as stated below;

Section 52.1 Shopping - Shopping is a method of procurement of Goods whereby the Procuring Entity simply requests for the submission of price quotations for readily available off-the-shelf goods or ordinary/regular equipment to be procured directly from suppliers of known qualifications.

52.1.b Procurement of ordinary or regular office supplies and equipment not available in the Procurement Service involving an amount not exceeding the thresholds prescribed in Annex "H" of this IRR.

WHEREAS, after thorough review of RA 9184 and its revised IRR, the BAC unanimously agreed that the Procurement of Reverse Osmosis System 2000 GPD with Installation is through **"Shopping"**;

NOW THEREFORE, on the basis of the foregoing, the herein members of the Bids and Awards Committee **HEREBY RESOLVE** as it is resolved to recommend that the Procurement of Reverse Osmosis System 2000 GPD with Installation will be procured through **Shopping**.
