This Bid Bulletin is being issued to clarify the issues and concerns raised during the Preliminary Bidding Conference held on **October 8, 2020, 9:00 AM** at the 2<sup>nd</sup> Floor, Board Room, Main Building of Mariano Marcos Memorial Hospital and Medical Center, Brgy. 6 San Julian, City of Batac, Ilocos Norte. This Bid Bulletin will form an integral part of the bidding documents. The following are the changes and additional requirements in the bidding documents:

CENDU 11	Single Use Injector for Gastro scope	921 needle with 4mm needle length
MS 324	Radiopaque balloon with multiple sizing 7FR/200cm catheter tapered to 5FR balloon diameter inflated to 8.5, 12 or 15mm injection above balloon	1 year expiration from date of expiration

**Other Instructions:**

**1. SAMPLES:**

There are three (3) ways in the submission of samples on the date of submission and opening of bids:

- The bidder/s shall submit its samples in four (4) sets, to be distributed to the Technical Working Group (TWG), Bids and Awards Committee (BAC), Materials Management Section (MMS) & End-users.
- The bidder/s shall submit seven (7) samples for spinal needle items.
- The bidder/s shall submit only one (1) set for the expensive items.

\*Sample/s of the bidder/s who will be declared as Lowest Calculated Responsive Bidder will not be returned.

- A copy of this Bid Bulletin should be attached in the last part of the Technical Proposal after the Omnibus Sworn Statement followed by the complete set of the Bidding Documents bought from the Bids and Awards Committee (BAC).
- All bids submitted after the deadline shall not be accepted by the BAC. The BAC shall record in the minutes of bid submission and opening, the bidder's name, its representative and the time the late bid was submitted.
- The bidder shall indicate/state in the Statement of Compliance, in the Technical Specification, against each of the individual parameters of each Specification the corresponding/equivalent performance parameter of the equipment offered.
- All other provisions of the bidding documents which are not affected shall remain in effect.

Furthermore, in accordance to Section 41 of the RA 9184 and its IRR, the Mariano Marcos Memorial Hospital and Medical Center reserves the right to reject documents which do not comply with the requirements, waive any formalities of documents or consider any submission of documents as substantial compliance, reject any and all bids, declare failure of bidding, annul the bidding process, or not award the contract, or if the funds/allotment for the program/project/activity has been withheld or reduced through no fault of the procuring entity without thereby incurring any liability to the affected bidder or bidders.
